1	Is there an anticipated number of assignments to be released for each service category?	We do not have an estimate of the number of assignments that will be released under each category. Under our previous Monitoring, Evaluation, and Research Master Service Agreement mechanism (which included many but not all services described in this RFQ), there were an approximate of 80 assignments released from 2021-2023: 36 in 2021, 22 in 2022, and 22 in 2023.
2	Is there an anticipated dollar value per assignment? OR any minimum/ceiling value for each Master Service Agreement?	We do not have an anticipated dollar value per assignment, which can vary greatly depending on the duration and scope of an assignment. There will be no minimum or ceiling value for assignments stipulated via a Master Service Agreement. Please note that successful firms will not receive Master Service Agreements, but rather will be added to a list of prequalified firms that are eligible to be invited to apply for Mercy Corps assignments. Contracting will be done on a project-by-project basis.
3	Could those companies accepted on to the prequalification pool be invited to submit proposals for all Mercy Corps countries, should needs arise?	Companies accepted into the prequalified pool will be eligible to submit proposals for all 40+ countries where Mercy Corps works, not just the countries listed in the LOE proposal section of the mock proposal template. 5	Please describe the contracting process within the mechanism?	Information about the Prequalified Pool and all vendors within the pool will be shared with all Mercy Corps teams. As needs arise, Mercy Corps teams will invite a select number of firms in the pool to apply for an opportunity via the online procurement portal, Ariba. Specific firms will be invited to apply for assignments based on their stated expertise, geographic availability, and various other factors. Should a firm be successful, the Mercy Corps team will draft a service contract (based on a standard template) for the assignment and share it with the successful firm for review and signature. Once the contract is signed, work can begin.

11	Does Mercy Corps recommend bidders provide the entirety of work samples (i.e., everything including Cover page, intro, methodology, findings, citations, etc.), or only specific sections? If the latter is the case, what sections does Mercy Corps recommend bidders provide?	Yes, bidders should provide complete work samples (all sections except for Annexes).
12	What specific equipment does "Avg. Value of Equipment and Materials on Hand (USD)" in the Supplier Information Form" entail, and should average values be provided for each type of equipment item or only the aggregate value of all equipment and materials on hand?	This section applies to suppliers that provide materials and products. Please ignore if you solely provide a service. If you do provide a product, then you can provide an average USD value of equipment or material to be sold.
13	To reduce the administrative burden for both Mercy Corps and potential suppliers, will Mercy Corps consider extending the shortlist validity to five years (rather than 24 months)? With a new RFQ re-issued after 12 months (which could be done annually on a longer RFQ), there is an on-ramp for new suppliers - and flexibility for MC to create new pools if needed?	Our internal procurement policies require that we open the pool to new applications every 12 months and re-tender the pool every 24 months. Please note the full RFQ will not be re-issued every 12 months – this is only for new suppliers to apply.
14	Will Mercy Corps clarify if the shortlist time period is for ordering or delivery? Do all task orders have to be contracted in the 24 months or completed in the 24 months?	The 24-month period is for ordering. In other words, all Service Contracts must be contracted in the 24 months, but work can extend past the 24-month.
15	If a Country or Project team uses the shortlist, will all pre-qualified suppliers in the pool receive the scope of work?	No. Mercy Corps will invite select vendors in the pool to apply for an assignment based on their stated expertise, past experience, geographic availability, etc. A minimum of 3 vendors will be invited to apply for each assignment (except in sole-source procurements). There is no maximum number of firms that can be invited for an individual assignment, but we do not expect that teams will invite every firm in the pool.
16	Are there any provisions for sole-sourcing task order/scopes of work to pre-qualified suppliers?	Yes, there will be provisions in place that will allow for sole sourcing for specific assignments as appropriate.

The inception report may contain information that ultimately becomes included/expanded upon in an impact evaluation protocol. It is an interim output between when the agreement is signed and the protocol is finalized. The inception report should directly inform the impact evaluation protocol by summarizing new insights based on program document review and initial meetings between the firm and Mercy Corps. The inception report should facilitate shared agreement between Mercy Corps and the firm on the impact evaluation objectives, document any revisions to the initial impact evaluation design as a result of preliminary meetings, outline roles and responsibilities, timelines and deliverables.
31	Reference to the Performance Evaluation Mock SOW Clarification on leveraging endline survey/quantitative analysis - While the SoW refers to an endline data collection period and a quantitative survey to be rolled out, the deliverables described do not make a direct reference to where the quantitative analysis will be used. Apart from the completion of IPTT tables, is there another specific place that quantitative analysis is meant to be captured or can it be rolled into the Performance Evaluation at the research firm's discretion?	In addition to the completion of the IPTT, the quantitative survey used for the endline data collection can be used to collect additional data if the firm feels it is needed to complete one or more of the evaluation objectives listed in section 2.2.
