Tender Notice

Mercy Corps is a non-religious, non-profit and non-governmental international humanitarian organization and aims to increase Agricultural production and resilience through provision of Certified Seeds for farmer cooperative in Gadaref state.

Mercy Corps is seeking a supplier/s to Provide certified seeds to farmers cooperatives at a subsidized price, to improve effectiveness and productivity and enhance seed accessibility for farmer cooperatives, enhance market linkages between smallholder farmers and Certified Seeds suppliers by creating a sustainable market-led seed supply model that benefits both parties in the long term and Offer training and demonstrations to raise farmer awareness of the benefits of climate-smart inputs, crop variation and full-service technical packages, focusing on cost-effectiveness and long-term productivity gains. The product with discounted prices will include provision of **Certified Seeds of Sorghum, Millet and Groundnuts**. The project is located at [East Gallabat, West Gallabat, Alfashaga & Basunda Localities].

1. Eligibility Criteria

Companies selected must meet the following criteria:

- 1. Legal Registration and Business Experience:
- a) Be incorporated in Sudan and registered with the commercial registrar as an Agriculture services providers or/and input importer, producer, processor, or marketer (excluding general merchandise sellers operating solely through tenders).
- b) Have at least two years of experience operating in Sudan as an Agriculture services providers company or input importer.

2. Seed Expertise and Quality Assurance:

- c) Demonstrated expertise in handling and distributing certified seed AND PREFERABLY Selling seeds of sorghum, millet, groundnuts, and vegetable seeds (tomatoes, onions, okra, cucumber, carrots, etc.) to smallholder farmers.
- d) Ability to provide evidence of seed certification and quality control measures.

3. Logistical and Distribution Capacity:

- e) Proven capacity to manage the logistics of seed delivery to remote rural areas within the specified localities.
- f) Access to adequate transportation and storage facilities to ensure timely and safe delivery of seeds at operation site.
- 4. Financial Stability:

- a) Has the capacity to meet the cost of activities, to initiate and provide the required products/service at an early stage / capacity to pre-finance and manage cash flow.
- b) Ability to provide financial records upon request and show proof of availability of in-kind

items like seeds, trucks etc...

- c) Capacity to handle the financial aspects of the subsidized seed sales program.
- d) Demonstrate a willingness to invest in expanding business in Gadaref, particularly in rural areas.

5. **Technical and Training Capacity:**

a) Have skilled agricultural staff, agents, and marketers to implement activities in close

collaboration with Farmer Cooperatives and Agricultural extension agents.

- a) Ability to conduct in-field training sessions for farmers and seed retailers.
- b) Experience in developing and delivering agricultural training programs.
- c) Apply using the attached template, clearly explaining how the listed activities will be

implemented.

- 6. Community Engagement and Networking:
- o Ability to establish and maintain relationships with farmer cooperatives and communities.
- o Experience in working with community extension teams (CETs) and rural agents.
- o Capacity to identify and engage with 100 rural seed retailers.

7. Compliance and Reporting:

- a) Ability to maintain accurate and detailed records of all transactions.
- b) Willing to use templates and digital platforms provided by Mercy Corps for record-keeping.
- c) Ability to provide timely and accurate reports on program activities.
- d) Commitment to transparency.

8. SME Status:

Must meet the definition of a Small and Medium Enterprise (SME) as will be defined by the country's official categorisation standards
