Mercy Corps is a non-religious, non-profit and non-governmental international humanitarian organization and aims to to increase Agricultural production and resilience through provision of fertilizer for farmer cooperatives in Gadaref state.

Mercy Corps is seeking a supplier/s to Provide fertilizers to farmer cooperatives at a subsidized price, enhance market linkages between smallholder farmers and fertilizer suppliers and Offer training and demonstrations to raise farmer awareness of the benefits of climate-smart inputs/ fertilizers and full-service packages, focusing on cost-effectiveness and long-term productivity gains. The product with discounted prices will include provision of **Fertilizer (DAP/ Urea)**. The project is located at [East and West Gallabat, Alfashaga and Basunda].

1. Eligibility Criteria

Companies selected must meet the following criteria:

1. Legal Registration and Business Experience:

- a) Be incorporated in Sudan and registered with the commercial registrar as an Agriculture services providers or/and input importer, producer, processor, or marketer (excluding general merchandise sellers operating solely through tenders).
- b) Have at least two years of experience operating in Sudan as an Agriculture services providers company or input importer.

2. Fertilizer Expertise and Quality Assurance:

- c) Demonstrated expertise in handling and distributing high-quality fertilizer AND PREFERABLY Selling fertilizer to smallholder farmers.
- d) Ability to provide evidence of high-quality fertilizer and quality control measures.

3. Logistical and Distribution Capacity:

- e) Proven capacity to manage the logistics of fertilizer delivery to remote rural areas within the specified localities.
- f) Access to adequate transportation and storage facilities to ensure timely and safe delivery of fertilizer at operation site.
